- **The Club docks, rack and property are maintained by the joint and volunteer efforts of the Club's members and are provided to the Member in good standing according to the Club By-Laws and Rules. The member acknowledges having read the By-Laws and Rules and agrees to comply with them.**
- **While the boat is on Club property or in the lagoon, the Member shall not hold The Halloween Yacht Club, The City of Stamford nor the Officers or Employees liable for loss or damages due to fire, theft, storm, collision, explosion, sinking, or vandalism, nor the bodily injury or damage that may be sustained by the Member or by the Member's boat, equipment or stores. Member further acknowledges liability for any such event and for damages there from to Club property.**
- **If the Berth Holder's boat sinks in the lagoon, for any reason, it shall be raised and removed by the Berth Holder within 72 hours at his or her expense. If not, the Club will have the right to raise and remove the boat and to bill the Berth Holder for all normal and reasonable expenses for the removal of the boat.**
- **The Berthing Committee reserves the right to verify the boat length and beam measurement and the assignment of berthing.**
- **Each Member must submit a copy of the current registration and insurance documentation (if not on file). Further, a new copy of the insurance certificate must be received by the Club within 30 days after the expiration date of the policy. Insurance minimum: \$100,000 of liability.**
- **Boats stored on land must be supported by wood and jack stands. Chain must be used between the starboard and port jack stands, fore and aft. All boats covered by a tarp or shrink wrap must display the member's seniority number.**
- **Failure to comply with berthing rules will result in a fine.**
- **Members who have not submitted a Stamford Residency form for 2019 - see winter storage notice for instructions.**

Note regarding co-owners and wait list: If there is a co-owner (other than spouse) of the above boat, co-owner must have qualified seniority greater than next most senior Member, on the wait list, applying for a space (co-owning Members must meet this and all other requirements for berthing).
